b) A FSTD User Approval will be issued for one complete year regardless of the expiry date of the FSTD qualification, and shall be dependent upon the continued qualification of the FSTD to the qualification level specified;

c) KCAA Inspector may be required to visit the FSTD for the purpose of evaluating the device for training and testing;

d) The FSTD Operator is the organisation to which the FSTD Qualification Certificate has been issued;

e) Users should note that the Qualification of an FNPT or BITD under JAR-FSTD A/H does not automatically mean that the device can be used for training. Users must gain Approval to use the device as part of their training programmes. It is possible that an Operator/Organisation could have a device that has been Qualified under JAR-FSTD A/H and that is used by more than one User. In such cases each User must apply for a separate Approval for their training programme but the device requires only the single Qualification.
