Pursuant to Article 21.2, 61 and 67 of the Law No. 03/L-051 on Civil Aviation ("Official Gazette of the Republic of Kosovo", Year III, No. 28, date 4 June 2008),

For the purpose of amending and supplementing the Regulation No. 1/2008, on Aerodromes dated 27 November 2008,

Upon completion of the process of public consultation of interested parties, in accordance with the Administrative Instruction No. 01/2012 on procedures for public consultation of interested parties,

Hereby issues the following:

# REGULATION NO. 4/2012 AMENDING AND SUPPLEMENTING REGULATION NO. 1/2008 ON AERODROMES

#### Article 1

The title of the Regulation No. 1/2008 shall read "Regulation No.1/2008 on Certified Aerodromes".

### Article 2

Article 1, shall be replaced as follows:

"The present Regulation applies to aerodromes including heliports available for public civilian use".

### Article 3

Article 2, the following amendments shall apply:

Definition for "Annex 14" shall be replaced as follows:

"Annex 14- means Annex Volume I "Aerodromes", and Volume II "Heliports", to the Chicago Convention".

The following definition for heliports shall be added following the alphabetical order:

"Heliport means an aerodrome or a defined area on a structure intended to be used wholly or in part for the arrival, departure and surface movements of helicopters".

#### Article 4

Article 4, paragraph 1 shall be replaced as follows:

"The operator of an aerodrome or heliport with annual traffic that exceeds 10.000 passengers per year or 850 movements related to cargo operations per year shall be in possession of an aerodrome certificate granted under the terms of the present Regulation".

#### Article 5

Article 11, paragraph 1, item (b) shall be amended as follows:

"The aerodrome facilities, operations or maintenance are not of the standard required in the interests of the safety of flight operations".

## Article 6

Article 21, paragraph 2 shall be replaced as follows:

"The operator of a certified aerodrome must ensure that the operations and maintenance of the aerodrome are carried out with a reasonable degree to ensure safety of flight operations".

#### Article 7

Article 27 after paragraph 1 the following paragraph shall be added:

27.2 An aerodrome operator shall notify CAA in advance of any development or before any, changes in the physical characteristics of the certified aerodromes that may affect the safety of the operations at aerodrome, major operational modifications, including the erection of new buildings and alterations to existing buildings or to visual aids.

Paragraphs after paragraph 2 shall be renumbered, so that paragraph 2 becomes paragraph 3 and so on.

# Article 8

The present Regulation shall enter into force on 10 October 2012.
