Pursuant to Articles 3.5 item (ii), 15.1 item (a), (c), (f), (j), 21.2, 78, 79 and 80 item (a) and (b) of Law No. 03/L-051 on Civil Aviation (“Official Gazette of the Republic of Kosovo”, Year III, No. 28, of 4 June 2008),

Taking into consideration,

International obligations of the Republic of Kosovo towards Multilateral Agreement on Establishing the European Common Aviation Area (hereinafter “ECAA Agreement”) since its provisional entry into force for Kosovo on 10 October 2006,

With the aim of implementing Regulation (EC) no 1070/2009 of the European Parliament and of the Council of 21 October 2009, amending Regulations (EC) No 549/2004, (EC) No 550/2004, (EC) No 551/2004 and (EC) No 552/2004, within the internal legal order of the Republic of Kosovo,

Upon completion of the process of public consultation of interested parties, in accordance with the Administrative Instruction No. 01/2012 on procedures for public consultation of interested parties,

Hereby issues the following:

AMENDING REGULATION No. 8/2009, ON THE SINGLE EUROPEAN SKY,
REGULATION No. 9/2009, ON THE PROVISION OF AIR NAVIGATION
SERVICES IN THE SINGLE EUROPEAN SKY, REGULATION No. 10/2009 ON
THE ORGANISATION AND USE OF THE AIRSPACE IN THE SINGLE
EUROPEAN SKY, AND REGULATION No. 11/2009 ON THE
INTEROPERABILITY OF THE EUROPEAN AIR TRAFFIC MANAGEMENT
NETWORK**

Article 1

Regulation (EC) no 1070/2009 of the European Parliament and of the Council of 21 October 2009, amending Regulations (EC) No 549/2004, (EC) No 550/2004, (EC) No 551/2004 and (EC) No 552/2004 is hereby declared applicable in the Republic of Kosovo. Regulation (EC) No 1070/2009 is annexed to this Regulation and forms its integral part.

Article 2

2.1 Applicable provisions of Regulation (EC) No 1070/2009 in the Republic of Kosovo are Articles 1 to 5.

2.2 Accordingly, provisions of Article 1-5 of the Regulation (EC) 1070/2009, shall amend the respective provisions referred to in the CAA Regulation No. 8/2009, No. 9/2009, No. 10/2009 and No. 11/2009 which have enacted into national legal order of the Republic of Kosovo the Regulations of the European Parliament and of the Council (EC) No. 549/2004, No 550/2004 (EC), No. 551/2004 (EC) and No. 552/2004 (EC).

2.3 Any provision of the future amendments of the Regulation (EC) 1070/2009, upon its becoming part of the Annex I or II of the ECAA Agreement, shall be directly applicable in the Republic of Kosovo.

Article 3

3.1 Definitions of terms and expressions used in this Regulation are those contained in CAA Regulation No. 8/2009, No. 9/2009, No. 10/2009 and No. 11/2009.

3.2 Notwithstanding Article 3.1, terms "Community", "Community law", "Community legislation", "Community instruments", "EC Treaty", "Community airport", "Official Journal of the European Communities", "Official Journal of the European Union", "Community air carrier" and "Member State(s)", referred to in CAA Regulations No. 8/2009, No. 9/2009, No. 10/2009 and No. 11/2009, shall be read in accordance with Points 2 and 3 of Annex II to the ECAA Agreement.

Article 4

In case of interpretation of the Regulation (EC) 1070/2009, the original version in the English language as published on the Official Journal of the European Union shall be used.

Article 5

This Regulation shall enter into force on 20 February 2016.
