The flight is not allowed at a distance less than 1 Km from Kosovo Administrative Boundary Line and 2 km from any aerodrome, any military base/camp, restricted/prohibited areas or gathering of KFOR troops (except for operation close to Camp Film City in Pristina for which the distance is reduced to 1 Km), unless specifically authorized by KFOR, as well as to obtain aerial imagery of the above mentioned locations.
