#### B. Documents to be submitted with application:

- 1. Applicable fee.
- 2. Confirmation of the payment for review (if review for the purpose of issuing certificate of airworthiness was performed by Civil Aviation Authority.
- 3. Recommendation for issuance of certificate of airworthiness, issued by the appropriate organization (only if review was not performed by CAAK)
- 4. Copy of current policy of mandatory insurance of aircraft
- 5. If review will be performed by CAAK, following documents, related to continuing airworthiness of the aircraft, shall be submitted:
  - a) Current list of all components with a limited life time, certified by the aircraft operator/ Part M subpart G organization.
  - b) Current list of all applicable airworthiness directives , certified by the aircraft operator/ Part M subpart G organization
  - c) Current list of all modifications and repairs.
  - d) Weight and balance report
  - e) Weight and balance report
  - f) Proof of calibration of pitot-static instruments
  - g) Proof of calibration of magnetic compass
  - h) Proof of testing of transponders
  - i) A copy of current valid certificate of organization for continuing airworthiness management, if there is a contract or the airworthiness review has been performed by that organization.
  - j) List of routine (scheduled maintenance) performed and replacing of components, dated from last airworthiness review with copies of relevant CRS.
